Remarks:

1) The offset register contains all current offset obligations. Such an offset obligation is imposed on foreign suppliers of defence materiel for procurements worth at least CHF 20 million. Usually, the offset obligation amounts to 100 per cent of the purchase price. The basis is a procurement contract and an offset agreement between the foreign supplier and armasuisse. The amount of the offset obligation and details of individual offset transactions are subject to business secrecy and may not be published.

2) An overfulfilled offset obligation is indicated with a minus amount. Replenishments can increase the offset obligation. The fulfilment of the offset obligation is measured in the currency of the procurement contract; where not in CHF, the currency rate on the reporting date of the offset register was used.

3) The consent of Swiss beneficiaries to publication in the offset register is given in the Offset Declaration Form (ODF) since 1 April 2018. Swiss beneficiaries in prior offset transactions may not be published.

4) Direct offset transactions flow into the defence materiel to be procured. Indirect offset transactions do not flow into the defence materiel to be procured.
